SELECT THE TYPE OF AWARD. The ABB Selection Committee will consider the following criteria in selecting the recipient for each award.

□ LAW FIRM/CORPORATE/PUBLIC AGENCY DIVERSITY AWARD

For an Arizona law firm, corporation, academic institution, non-profit or public agency that demonstrates achievement and sustained commitment to diversity and inclusion in the legal profession for racially and ethnically diverse lawyers in Arizona.

- ➤ Employs a diverse workforce, promotes and encourages racially and ethnically diverse attorneys furthering diversity and inclusion in the Arizona legal profession
- ➤ Takes specific efforts to advance and promote full and equal participation of racially and ethnically diverse lawyers in the Arizona legal profession
- ➤ Demonstrates active participation and leadership in minority bar organizations and community events that promote diversity and inclusion
- ➤ Demonstrates corporate responsibility by devoting resources to minority organizations for the improvement of diversity and inclusion in the legal profession, including financial support of non-profit minority organizations boards and committees, Pro bono services benefitting the advancement of diversity and inclusion, sponsorship of minority community events that encourage diversity and inclusion of law students and attorneys or presentations and/or panelists at programs geared to increase the number of minority attorneys in Arizona

2018 HAYZEL B. DANIELS SCHOLARSHIP APPLICATION

The Arizona Black Bar will be awarding scholarships to assist third-year law students with the cost of the bar preparation course for admission to the State Bar of Arizona. Applicants must prepare and submit an essay and meet the criteria listed below. The submission deadline is **July 31, 2018**.

- The applicant must be a third-year law student.
- The applicant must be an active member of the law school's Black Law Student Association (BLSA). If the applicant's school does not have a BLSA chapter, the applicant shall discuss his/her involvement in a comparable organization.
- The applicant must obtain a letter from the BLSA President, the BLSA academic adviser, or the manager of the comparable community organization if no BLSA chapter is present. The letter should state that the applicant is an active member of the organization.
- The applicant must provide an unofficial transcript, indicating a minimum GPA of 3.0.
- The applicant should provide a statement explaining his/her need for financial support for the bar preparation course. The applicant should explain how he/she will work to further diversity and inclusion within the legal community as well as the public. The applicant should also explain the type of involvement he/she intends to have with the Arizona Black Bar as a practicing attorney.
- In applicant's essay, the applicant must affirm that he/she intends to practice law in Arizona.
- The applicant must submit the completed materials to the student's Financial Aid Department no later than July 31, 2018.

Once the applicant's essay has been submitted, the following will occur:

• The Law School's Financial Aid Department shall review the applications and forward the pool of applications and essays meeting the minimum criteria outlined above to Kina Harding at ArizonaBlackBar@gmail.com or by fax to The Harding Firm at 480.626.7663.

- A selection committee will review the submitted, eligible essays for possible selection as the scholarship recipient.
- The selected recipient will be presented with the scholarship at the Arizona Black Bar Hayzel B. Daniel Scholarship Gala on Thursday, October 12, 2018 at the Legacy Golf Club. The applicant's attendance is requested.
- The funds for the bar preparation course will be disbursed to the recipient by the Arizona Black Bar.
